ORAL AND WRITTEN COMMUNICATIONS

1. PRESENTATION –

1-A. Kimley-Horn presented an overview presentation on Monterey Pass Road Complete Street Project to help the city with community outreach, design and define the limits of the project.

The project is a 1.6-mile corridor extending from Floral Drive to Garvey/Fremont Avenue. This project is defined as a complete street project aim to balance the needs of all modes of transportation and users along the corridor.

Project Goals:

- Develop accessible and safe pedestrian facilities
- Facilitate different modes of transport such as cars, buses, bikes, etc.
- Encourage and making cycling a more attractive and convenient mode of transportation compared to driving
- Optimize traffic operations
- Integrate sustainable improvements such as EV charging

MISSION STATEMENT

The mission of the City of Monterey Park is to provide excellent service, foster growth and opportunity, and create a joyous and collaborative environment.

1-B. Garvey Avenue Improvement Project:

Engineering Manager Mazboudi presented an overview presentation on Garvey Avenue Improvement Project. The City received funding from LACMTA to fund the development and construction of the Garvey Avenue Capacity Improvements project, from West Atlantic Blvd. to New Avenue. The project is approximately 1.7 miles in length.

The project is anticipated to improve the following:

- Public transit/bus flow
- Pedestrian mobility and safety
- Promote bicycle use by evaluating routes & usage on adjacent streets
- Traffic flow, reduce congestion, thus reduce emission of greenhouse gases
- Promote electric vehicle use providing EV charges for public use

1-C. 1st Riggin and Potrero Grande Corridor Improvement:

Engineering Manager Mazboudi presented a presentation on 1st Riggin and Potrero Grande Corridor Improvement. The City received funding from LACMTA to fund the development and construction of the 1st Riggin-Potrero Grande Corridor. The project encompasses several following jurisdictions including Cities of Monterey Park, Rosemead and Montebello. The project proposes to expand alternative modes of travel by increasing the existing bicycle transportation network and enhancing pedestrian facilities.

1-D. New Citywide Speed Limits Update:

All signs have been replaced with new speed limits.
